LIFE MEMBERSHIP NOMINATION

GENERAL INFORMATION

Life Membership of the Torquay Football Club is an award given to individuals who are considered to have provided outstanding service or contributed to the Club through outstanding achievements well beyond that of a typical member.

It is not necessary for life memberships to be awarded every year.

Nominations for Life Membership can be made by current or past members of the Club. The nomination must be in written form, addressed to Torquay Football Club Life Membership Panel and be received in a sealed envelope by the Club administrator prior to 31st July of the relevant season.

A panel of Life Members will be convened by 31st July each year and a Panel Chairman elected. The panel will consider the eligibility of any nominations for Life Membership received in the current season. Should the panel grant the award of Life Membership to a nominee or nominees, the Panel Chairman will advise the current committee of any successful nominations which will be ratified at the Torquay Football Club Inc. Annual General Meeting for that season.

The Panel of Life Members, in considering the eligibility of any nominees, will refer to a range of assessment criteria. As the Panel must be able to verify the details of the nominee's service or achievements it is important that nominator provide accurate and detailed information of the nominee's service to the club.

Nominations must be submitted by the 31st July (yearly).

Note: By nominating a person for life membership you the nominator declare that the information is true to the best of your knowledge and propose the nominee be considered for Life Membership of the Torquay Football Club.

LIFE MEMBERSHIP NOMINATION

For the Life Membership Panel to be able to assess a nomination for Life Membership of the Club the submission must be in written form and contain details of the nominee's service including but not limited to the following:

1. Detail any committee roles the nominee has held including years in those roles.

eg. Committee Member 2000 -2004, Vice President 2005-2008, Football Manager 1994-1997

2. Detail any voluntary and or support roles held by the nominee including years in those roles.

eg. Timekeeper 1995-1998, Thursday meals preparation 2010-2018

3. Detail any senior coaching/manager roles held by the nominee, and relevant years.

eg. Senior Assistant Coach 1985-1990, Senior Selector 2004-2008, Reserves Team Manager 1975-1979

4. Detail any junior coaching/manager/coordinator roles held by the nominee, the level and relevant years.

eg. U/14 Coach 1985-1990, Team Manager U/16 2010-2018, Auskick Coordinator 2008-2011

5. Detail any operational/support roles involving game day duties including relevant years.

eg. Canteen Volunteer 1975-1985, Grounds Preparation 1971-1981, Volunteer Trainer 1965-1974

6. Detail any playing history for the club at senior level including relevant years, club playing awards.

eg. Senior Player 2001-2009, Club B&F 1995, 1997

7. Detail any playing history for the club at junior level including relevant years.

eg. U/16 Player 2010, Captain 2011

8. Detail any club service awards received by the nominee including title of the award and relevant years.

eg. Jack Jennings Award 1978, Bronny Award 2016

9. Any other information and detail that may be relevant for the nomination.
